## Texas

Tort reform changed Texas litigation in a big way a few years ago, rendering some products liability areas dead, while doctors flocked to the state seeking its strong medical malpractice protection. East Texas remains a hotbed of intellectual property litigation, even if the number of cases brought there has slowed the courts down, contrary to its "Rocket Docket" image. The oil and gas industry remains the engine driving Texas litigation, particularly as hydraulic fracturing opens up large natural gas fields previously unavailable. In recent years, lawyers note that the industry has been involved in substantially more antitrust and international arbitration matters.

#### **Highly recommended firms**

#### Baker Botts

Houston-based Baker Botts has been around, under various names, since 1840, growing in prominence along with the oil industry in the early 1900s. Baker Botts has several partners with high-level government experience and has built a significant reputation in white-collar defense and government investigations, due to strong connections to both Presidents George HW Bush and George W Bush, who once worked in the mailroom. The firm is also noted for its strength in oil and gas, antitrust, and commercial litigation. The Houston office is particularly strong in energy litigation, with strong connections in most key energy markets worldwide.

When Rod Phelan takes a case, peers know it will receive the full attention it deserves. "Rod Phelan is a scorched-earth, no-stoneunturned, aggressive litigator," says a competitor. Another adds, "Rod Phelan [is a] terrific lawyer, works very hard, is very smart, is a good writer, and is very much at ease in the courtroom." Travis Sales focuses his practice on products liability, representing clients like Merck, AstraZeneca and BASF. "Travis Sales should move up to litigation star," says a peer. "He specializes in big defense cases, like product defect cases. [He] defended the Vioxx case and got a very good defense result." Working out of Dallas, Van Beckwith draws praise for his intelligence and creativity. "Van Beckwith's command of the facts is extraordinary and effective," says a competitor. "He developed a very creative case against us." Beckwith handles commercial and class-action matters, particularly for the food and beverage industries.

#### Beck Redden & Secrest

Established in 1992, Beck Redden & Secrest quickly established itself as a premier litigation boutique. "All the lawyers there are absolutely top-notch," says a competitor. The firm has represented major clients like 3M, ExxonMobil and Cameron International.

Over the course of his career, David Beck has firmly established himself as one of the top litigators in the country. "David Beck is an outstanding trial lawyer who is well known and respected throughout Texas and the nation," says a client. Peers are equally impressed, praising his talent, as well as his integrity. "David Beck is one of the preeminent trial lawyers in Texas," says a competitor. "David brings intellect and integrity that few others can bring; juries trust him, because he is honest as the day is long." Joe Redden, Jr and Fields Alexander recently represented Cooper Cameron against claims that its frac mandrel infringed on a patent owned by Duhn Oil Tool. The judge ruled that Duhn's patent was invalid, due to being anticipated or obvious. When Dr. Ebrahim Bagherzadeh had a dispute with his former employer, Marcus Oil & Chemical, over \$20 million he claimed he was owed for relinquishing his intellectual property rights to a new technology he invented, he turned to Murray Fogler, who won him the full payment, plus attorney's fees. "Murray Fogler is a superb lawyer," says a peer. "He's lowkey, but extremely effective in the defense of a case." David Gunn is widely respected for his appellate practice. "My go-to appellate lawyer is David Gunn at Beck Redden," says a competitor. "He is terrific and cerebral."

#### Fulbright & Jaworski

Founded in Houston in 1919 by a railroad regulation expert, Fulbright & Jaworski now has over 900 lawyers in 17 offices in the US, Europe, Asia and Middle East. The Houston office has over 250 lawyers known for their expertise in antitrust, intellectual property, mass tort, products liability and securities matters. Within Texas, the firm also has offices in Austin, Dallas and San Antonio. Mark Baker co-heads the firm's international department, as well as its arbitration and ADR practice group. Peers consider him a leading voice on international disputes. "Mark Baker has done a remarkable job of specializing in international arbitration and being one of the leaders of that." Working out of the Dallas office, Karl Dial handles complex commercial matters with seeming ease. "Karl Dial is a highly regarded commercial litigator in Dallas," says a competitor. "He is one of the best complicated commercial guys I have seen. [He] makes

complex matters simple." A certified public accountant, Dial handles director and officer liability, securities, legal and accounting malpractice, information technology, and intellectual property litigation. Noted for his products liability practice, Steve Dillard chairs the firm's global litigation department. "Steve Dillard is one of the guys in products liability," says a competitor. "He is successful, well regarded by the judges, and has been doing this for a long time; clients trust him." A partner in the Houston office since 1978, Dillard has recently devoted his practice to environmental, groundwater contamination, chemical exposure, and toxic and mass tort cases, including class actions.

With around 30 lawyers, Gibbs & Bruns operates as a lean litigation boutique, taking and winning big cases, both as a plaintiff and defendant. The firm touts its plaintiffs experience, claiming that approaching all cases with a plaintiff's mentality give it an edge. "We are still a client and would look to them for representation in significant commercial disputes, either as a defendant or plaintiff," says a client. "The firm is recognized as a true trial firm with a highly competent appellate and legal research capability." Another adds, "I believe they have the best plaintiff's lawyer reputation in Texas for serious business disputes."

While Kathy Patrick epitomizes the bulldog litigator image, multiple peers who worked alongside her also felt she was the smartest lawver involved in the case. "She beat the tar out of us in a case," says a competitor. "We settled." Patrick recently represented 22 mortgage-backed securities investors who sued Bank of America to force them to buy back the investments, securing a, \$8.5 billion settlement that surprised industry analysts who expected a longer fight. When Texas billionaire Trevor Rees-Jones sold his energy company in 2006, it came as a surprise to former minority shareholder Bobbitt Noel, Jr, who recently allowed Rees-Jones to buy out his shares based on what he claimed was a much lower valuation of the company. Grant Harvey took the case, and in May 2011, a judge handed down a \$196 million judgment, citing fraud and breach of fiduciary duty. Specializing in complex commercial litigation, Barrett Reasoner draws praise for his approach. "Barrett Reasoner is professional, respectful of opponents, but aggressive and hones in on the issues very quickly," says a competitor.

#### Lynn Tillotson Pinker & Cox

Operating out of Dallas, Lynn Tillotson Pinker & Cox has been drawing the attention of fellow litigators recently. "Lynn Tillotson gets overlooked," one competitor says, with another adding, "In the Dallas marketplace, they show up in all the high-end stuff." The firm represents *Fortune 500* corporations, major financial institutions and prominent

individuals, including Southwest Airlines, Visa and American General Finance. "By God, they try cases," marvels a competitor.

Having handled over 90 civil and criminal jury trials and over 100 non-jury matters, Michael Lynn brings a wealth of experience to his matters, winning over \$300 million for his clients over the years. "Mike Lynn is fantastic," says a peer. In the past few years, Jeffrey Tillotson has handled complex commercial matters in over a dozen major multi-party cases brought in courts in nine different states for some of the country's largest financial and commercial companies. Trey Cox specializes in disputes between businesses. In 2010, he obtained a multimillion-dollar arbitration award for two executives on their breach of contract claims and secured a take-nothing verdict for a real estate developer accused of unjust enrichment. "Trey Cox is a youngish, very smart, very well regarded commercial lawyer who does a fair amount of plaintiffs work, but big in defense, too," says a competitor.

Douglas Cawley won a \$290 million judgment for i4i against Microsoft recently, convincing the judge that technology used in Microsoft Word infringed on an i4i patent. The case, which was decided by the US Supreme Court, was closely watched, as observers believe it will shape how patent cases are handled in the future. Peers refer to Samuel Baxter an intellectual property sage, with intimate knowledge of the Eastern District of Texas. "The man you really want to identify as the IP star over there right now is Sam Baxter," says a competitor. "He is the true star." Michael McKool handles some of the firm's largest litigation, including work for clients like Lockheed Martin, American Airlines and Excel Communications, drawing praise beyond Texas for his commercial and intellectual property work. Theodore Stevenson III has over 20 years experience handling intellectual property disputes for clients like Medtronic, Ericsson and Omni Financial. "Ted Stevenson is a really fine, mostly plaintiffs, IP lawyer," says a peer. Lewis LeClair draws praise from peers for his work. "Lewis LeClair is exceptional bright, a great organizer and a great leader of a team,' says a competitor. LeClair handles commercial and intellectual property matter. Another peer adds: "Lew LeClair is a stud."

Though small in size with only 13 lawyers, Smyser Kaplan & Veselka draw respect for their tireless litigation. When quizzed about the firm's litigation acumen, one competitor replied, "Oh yeah, now they go to trial." The firm represents both plaintiffs and defendants in multimillion-dollar cases, trying cases in state and federal courts throughout the US, as well as the US and Texas Supreme Courts. The firm recently represented Del Monte Fresh Produce against a breach of fiduciary

"Kenny Marks is a good questioner, off the cuff and pretty thoughtful," says a competitor. duty claim brought by James J Flanagan Shipping, seeking 10 years loft profit, worth \$5.6 million, plus \$25 million in putative damages. The dispute arose after Del Monte terminated a three-year shipping contract one year into the agreement. Flanagan alleged that Del Monte conspired with a competing company and a disloyal Flanagan employee. The firm won a take-nothing judgement.

Lee Kaplan has handled patent and trademark infringement, oil and gas, antitrust, criminal and civil fraud, Foreign Corrupt Practices Act, trade secrets, shareholders' rights, insurance coverage, and class-action matters. He currently represents Software Rights Archive in a patent infringement case brought against Google, Yahoo!, Lycos and AOL, potentially worth over \$100 million. It is scheduled for trial in December 2011. Craig Smyser handles commercial and personal injury disputes. In April 2011, he won a takenothing judgment for Celotex against claims that the company knowingly sold property contaminated by asbestos underground. The plaintiff, Warehouse Associates, claimed \$16 million damages at trial.

Established in Houston in 1917, Vinson & Elkins is a prominent player in both Texas and Washington DC litigation. Long an energy powerhouse, the firm's antitrust, intellectual property, environmental and white-collar crime practices have drawn increased attention over the years. "The firm has represented us since our inception," says a client. "They remain one of our counsels of choice. I need litigators who understand the nature of our business and factor those realities into their thinking on litigation."

The firm has suffered several high-profile departures recently, for health reasons and otherwise, losing litigation stars Karen Hirschman, William Dawson and Knox Nunnally, but still retains depth in its Texas litigation group. Working out of the Dallas office, Williams Sims carries over 37 years experience. He recently represented Baron & Budd, a leading plaintiffs firm, against claims of breach of contract, fraud, and tortious interference brought by attorney Roger Worthington, winning a dismissal with prejudice. Marie Yeates, noted for her appellate practice, represents the Fluor Corporation convincing an appellate court to overturn a \$100 million tortious interference verdict against the firm. The firm is currently handling the retrial. When BreitBurn Energy faced fraud charges arising out of a \$1.5 billion oil and gas properties acquisition from Quicksilver Resources, Karl Stern managed to settle the matter out of court. Stern, a 30-year veteran of antitrust, energy and financial litigation, is considered a standout among peers for his professionalism. Lee Kaplan obtained his first jury verdict as lead counsel in October 1978, when he persuaded the jury that his client's air conditioner did not cause a house fire.
